Information for Applicants

ITI MAKErS is pleased to invite researchers from around the world to apply for the position of Visiting Scholar for the Academic Year Y/Y+1, with the aim of continuously fostering its Internationalization process.

Scientific field

Candidates may apply for one of the following Departments:

- Economics
- Law
- Political Science and sociology

Duration and Visiting Periods

The fellowship lasts up to 3 months outside mid-July to the end of August.

- Fall Term : September 1 December 20 (Year Y)
- Spring Term : January 15 July 15 (Year Y+1)

While stays longer than 3 months are welcomed and desired, the department normally funds fellows only for 3 months (90 days), but provides office space and full library privileges for the entire duration of stay.

Residence

Fellows must live in Strasbourg for the duration of the fellowship so that they can take an active part in the academic activities of their research lab.

Stipend

ITI MAKErS will provide a lump sum compensation to cover travel and living expenses throughout the Visiting period. The daily stipend is $100 \notin$ for a minimum of 30 days (3 000 \notin) and up to 90 days (9 000 \notin).

This payment will also remunerate a moderate teaching involvement in ITI MAKErS classes and seminars (Master's degree and doctoral programme).

Taxation

The fellowships are not taxed by the University of Strasbourg. However, fellows are required to comply with any tax requirements which may be applicable to them.

Important Deadlines

The call for Application is open permanently. However, applications will be examined according to a fixed schedule (see info on the <u>dedicated page</u>)

Results will be notified within 10 days thereafter.

Selection procedure and criteria

Candidates are selected by the ITI MAKErS Research Committee.

Required Documents

- Application Form
- CV
- Research proposal closely linked to MAKErS research axe(s)
- Employer declaration for a visiting researcher / professor (see attached model)
- Bank account statement in the name of the visiting professor/researcher

Eligibility

The fellowships are open to established academics with an international reputation. Post-doctoral fellows are not eligible.

Nationality

Candidates of all nationalities are eligible.

Languages

Fluency in French is desirable but not required. Fellows should have a good knowledge of English and of any other language relevant to their proposed research.

Medical Insurance

Fellows must have adequate medical insurance cover during their stay at the Institute. They can either provide proof of their own insurance scheme or subscribe a private sickness and health insurance scheme at their own expenses.

Travel and Removal/Installation Expenses

There is no provision available for travel expenses. There is no provision available for removal or installation expenses.
